

MY SALON Suite Unlock Your Dream Suite OFFICIAL CONTEST RULES

CONTEST DATES:

- January 3 through February 13: contest entry period
- February 14-24: judging by panel of MY SALON Suite Featured Members and Suite Management Franchising (Carrollton, TX) company representatives
- March 1-13: public voting
- March 2023: Winner announced

WHO MAY ENTER: Contest is only open to U.S. residents, at least 18 years of age with valid email address. Contestants may need to provide proof of residency upon request. Contestants must also have an active cosmetology or esthetician license in order to apply for the contest. No purchase is necessary to participate in the contest.

CONTEST OBJECTIVE:

Starting January 3 thru February 13, 2023, contestants can enter contest for one (1) chance to win **one (1) year of** complimentary Membership ("**prize**") in a suite at a MY SALON Suite location.

CONTEST ENTRY:

WINNER NOTIFICATION: Winner will be determined after the public voting end date and will be notified in March 2023.
